

## **The Trial of the Century.....**



Kids get a real life lesson in how a Federal Trial works, thanks to UC resident, the Hon. John Hargrove

On February 9, 2007, two Fifth Grade classes of Spreckles Elementary School, accompanied by their teachers, Daniel Logue & Carlos Pacheco and several parents, visited the historic United States Bankruptcy Court for the Southern District of California, at 325 West F Street in downtown San Diego.



## That was Then...This is Now...Three Generations...



*Ed, his son Bob and grandson John....have lived in UC for 44 years...*

For 44 years, the Cox family has resided in UC. Three generations now call it home. Moving from Allied Gardens to a newly constructed house on Ithaca Place in 1963, Ed Cox, his wife Flora Mae, and son Bob were some of the community's first residents. "Friends thought we were moving to the middle of nowhere," laughs Ed. "The only access was Genesee. No 805 or 52 - and Governor Drive didn't go through. And, it took awhile for the promised schools to be built," continues Ed. "Curie was opened the year we moved here, but it was a number of years before a student could attend junior and senior high school right in the neighborhood." Ed, now a widower who will turn 88 the end of May, has enjoyed watching UC grow and prosper. Retired from General Dynamics, and a dedicated volunteer, he is in his 11th year transporting children from Tijuana to the Shriner's Hospital for Children in Los Angeles. Each of the children suffers from burns or crippling diseases.

In a typical year, he makes the 250+ mile round-trip more than 60 times! Son, Bob, met his wife (also a UC resident) while clerking at Big Bear Market. Working first at Bradshaw, and then Big Bear during high school and college, Bob is remembered by many long-time residents for the fun he provided those passing through his check stand. After a number of years in customer service positions with SDG&E and the City of San Diego Water Utilities, Bob, whose home is off Agee, is now the proprietor of an antique business, specializing in wind-up phonographs. Grandson, John, is keeping the UC tradition alive. He and his sister (the mother of the 4th Cox generation, Sean and Harriet, now residing in the Bay Area) were both born at Scripps Hospital. Living on Huggins Street in a house once owned by his maternal grandparents, John, a graduate of University of San Diego High School and Cal State San Marcos, is the marketing strategist for Althea Technologies, a thriving local biotechnology firm.

work out details after Anne Bolton got the Village Garden Club together with UCCA. ### Let's Clean Up Our Act..

Spring has sprung and the time has come for the **University City Community Association** with the help of "I Love a Clean San Diego", "Keep California Beautiful", and "Recycle San Diego", to sponsor the annual **UC Spring Clean-Up on May 12th, 2007**. The event will be held from 8:00 A.M. to 12 Noon in the Swanson Swimming Pool Parking lot, at 3585 Governor Drive. **Mayor Jerry Sanders** will be in attendance to help UC clean up. So bring your junk and common down.

Only items that can go into the landfill are allowed to be discarded. Items not allowed include hazardous waste, metal (ex. bed frames, fencing), appliances, garden and green waste, tires, electronics, or recyclable items. We are fortunate that this year "Recycle San Diego" will accept electronics such as printers, scanners, fax machines, televisions, VCRs, DVD players, computer monitors, telephones and cellular telephones.

There is usually a charge to recycle these electronic items, but Recycle SD will accept them, this year, without charge. Check out the complete list of items on the Recycle SD website: <http://www.recyclesd.com/even-titems.pdf>

....After disposing of your household discards, join us in cleaning up our sidewalks and medians in University City. ## Did You Know?...

...There is a way to get relief from party houses in your neighborhood. The San Diego Police Department has revised the **CAPP (Community Assisted Party Program)**. The police identify party locations primarily through calls generated by citizen's complaints about noise, crowds, late hours and party duration. To report a loud party in progress, call the police non-emergency number, **619 531-2000**. On the first visit, the police may issue a **First Response Notice**, a written warning that the party is disruptive, and the host must take immediate steps to control the situation. The First Response Notice starts the **CAPP** process.

First Response Notices are tracked by computer. Two or more First Response Notices in a 30 day period or anytime a **Second Response Notice** is issued will result in the house being CAPP'd. A second response to the address may result in the host being charged for the full cost of police resources being used in the second response. This is in addition to all other enforcement options, including arrest, impounding of stereo & amplifier equipment, kegs, etc. Once a house is CAPP'd, the residents and owner are notified the house is CAPP'd for one year, and there is a zero tolerance policy for any future disruptive parties. Per the CAPP brochure, "Under the California Penal Code Section 415.2, 'Any person who willfully disturbs the peace of another by loud and unreasonable noise' is guilty of a misdemeanor punishable by imprisonment in jail and a fine of \$400." "Under the Municipal Code, the person(s) responsible for the event may be held liable for the cost of providing police services...up to \$500."...

...The **San Diego County Board of Supervisors** used tobacco settlement funds to initiate the **Cancer Navigator program**. This program is designed to serve as a central resource for those trying to find local cancer information and services including support groups, clinical trials, treatment centers, etc. Both a website, [www.cancernavigator.org](http://www.cancernavigator.org) and a toll free Help Line **1-866-324-2648** are available. The website also provides links to national websites. **The Help Line hours** are Monday - Friday from 9:00 a.m. - 5:00 p.m. After hours, callers can reach the American Cancer Society's helpline at 1-800-ACS-2345...



## Scholar-Leader-Athlete



Brooks Dougherty of University City High School

Brooks Dougherty of University City High School has been named a scholar-leader-athlete by the Walter J. Zable/San Diego Chapter of the National Football Foundation and College Hall of Fame, it was announced today.

Dougherty will be honored with 29 other San Diego County high school and college football players at the chapter's 35th Annual Awards Banquet March 9, 2007 at the Scottish Rite Masonic Center in Mission Valley. All of those to be honored have demonstrated exceptional academic, citizenship and athletic achievements during the past year. In addition, special awards will be presented to two football coaches and an outstanding football official from the San Diego community.

He is a 6-foot-2-inch, 185-pound quarterback. Along with being selected to the All-Central League first team, Dougherty was named the league's Offensive Player of the Year. He was also voted University City High School's Most Valuable Player on offense. With a grade point average of 4.42, Dougherty was selected to the San Diego Union Tribune All-CIF Academic first team. Dougherty was also a three year letterman in basketball and was the team's leading scorer in 2006. In his spare time, Dougherty volunteers with the Challenger League, an organization that brings athletics to disabled youth.

He is the son of Drew Dougherty and Heidi Hansen.


