Looking Back: 2015 Accomplishments

2015 has been a great year as • Adopted the City's Climate Council President, full of collaboration and achievements. I am proud of the Council's accomplishments this past year, and I'd like to thank everyone for their support and wish you all Happy Holi-

Citywide successes include:

- Adopted a fiscally sound budget that restores funding for public safety, neighborhood services and infrastructure, while funding San Diego's reserves and unanticipated needs
- · Initiated and chaired the Charter Review Committee, to update our city's Charter • Approved agreements with for the 21st Century
- Passed the Zero Waste Plan, reducing San Diego's carbon emissions and alleviating strain on our landfill

- Action Plan, with plans to have 100% clean electric energy use by 2035
- · Advocated for federal resources to be directed to San Diego on a trip to Washington, D.C.
- Supported cybersecurity initiatives in San Diego
- Worked on educational initiatives by supporting programs like the Festival of Science and Engineering, Girls in • Funded additional hours for Engineering, and FIRST Robotics
- setting aside \$15 million for Christened a new Lifeguard fireboat, improving public safety in District 1 and at all our beaches and bays

District wide successes:

- Completed the Solana Ranch Park in Pacific Highlands Ranch
- Received funding for a Fire Rescue FAST Response Squad for South University City, and began planning a new fire station in Northeast **University City**
- Completed hundreds of work requests, including sidewalk repairs and pothole fills
- the Carmel Valley and Swanson Community Pools
- Installed crosswalk flashing beacons on La Jolla Blvd. to make Windansea safer for pedestrians

San Diego City Council Adopts the Climate Action Plan

On Dec. 15th, the City Council voted unanimously to adopt the Climate Action Plan, which establishes a roadmap for the City to achieve the greenhouse gas (GHG) emission targets established by the State of strategies for achieving targets involving water, energy, transit, land use, zero waste, Plan is expected to come to and climate.

The plan aims to reduce citywide GHG emissions by 20% in 2020 and 50% in 2035. The Plan sets ambitious targets, including achieving 100% renewable electricity by 2035 and a 50% increase in alternate trans-California. The plan includes portation (walking, biking and public transportation) by 2035. An Implementation

Council by the summer. The City's first Climate Protection Plan approved in 2005 focused on reducing emissions from municipal operations. In 2010, the City developed a more comprehensive Plan outlined actions that the City and community could take to reduce emissions consistent with state requirements.

Charter Review Committee Updates and Upcoming Agendas

At the December 3 meeting, the Committee asked for another preamble draft, approved language for the Planning and Ethics Commissions, and changed the Commission's name to City of San Diego Fair Political Practices Commission. It also asked the Mayor's staff to look into working with the Zoo to leverage the zoological exhibit tax for a general obligation

bond benefitting Balboa Park. The San Diego City Employee's Retirement System received support for reciprocity with the state retirement system, as well as staggered Board and independent legal counsel terms.

On December 8, Council voted to ask for voter approval for Charter changes regarding the City's Budget Process, Taxation, Bond Issuance, Financial Operations, and use of gender-neutral language.

On January 13, the Committee will consider publicly-submitted ballot proposals.

Flood Preparedness for Your Home and Vehicle



Flooding causes home damage and unsafe driving conditions.

Each year, winter storm flooding threatens San Diego homes and roads, causing expensive repairs and dangerous driving conditions. Fortunately, residents can take steps to reduce damage and drive more safely.

Purchase Flood Insurance:
Flood damage is not covered
by traditional homeowners'
insurance and is only available through the National
Flood Insurance Program

(NFIP). San Diegans living in areas with any risk of flooding should purchase insurance through the NFIP immediately. Learn more at www.floodsmart.gov.

<u>Check Your Tires:</u> Driving with less than moderate tread on a wet surface is a major factor in skidding. Tires should have at least 3/16" tread and be properly inflated.

Look at Windshield Wiper
Blades: Streaks can hinder

visibility. Change blades that cause streaks and ensure the washer solvent is full.

Check Headlights, Brake
Lights, and Defroster: Driving in rain means reduced
range of vision. Properly
working head lights and defrosters can help you see,
and help others see you.

<u>Drive Carefully!</u> Slow down, avoid standing water, and always obey caution signs placed by city crews.

One Paseo Revised Plan Available for Public Comment



Carmel Valley Community Plan available for public comment

A draft Community Plan Amendment (CPA) for Carmel Valley for the One Paseo project is now available for public review and comment.

Proposed changes include:

- A land use map that changes the Employment Center to a Community Village
- Text changes to the Carmel Valley Community Plan to accommodate the proposed land use change
- Text referencing a separate

Precise Plan document to the Carmel Valley Employment Center Precise Plan

 One Paseo Precise Plan Amendment

One Paseo, which is a 24 acre site located at the corner of Del Mar Heights Road and El Camino Real, has a revised plan that includes: 680 multi-family residential units; 95,871 ft² of retail commercial use; 280,00 ft² of office commercial use; and areas for civic use, open

space, and parking.
