University City Celebrates Opening of New Aquatic Center

San Diego Unified School District and the City of San Diego celebrated the opening of a joint-use pool near Standley Middle School on Thursday, April 7, 2022. A highly anticipated project for the community and nearby schools, the expanded aquatic center includes a new pool and pool amenities building, an outdoor pavilion for school and community gatherings, and a walking and running path. University City High School (UCHS)'s swim and water polo members took the first monumental lap on Thursday, with chants and a drumroll from the school's cheer and drumline teams, and applause from attendees, including San Diego Unified Board of Education Vice President Sabrina Bazzo, City of San Diego Councilmember Joe LaCava, and Former Board of Education Trustee Dr. John Lee Evans. This pool is part of the Play All Day partnership between the San Diego Unified and the City of San Diego, meaning it will be used exclusively by students at designated times and open to the public at other designated times. The UCHS teams plan to use the new pool for practice starting April 8."It's a game-changer for our swim and dive teams," said UCHS Principal Michael Paredes. "Our teams had to travel outside of University City for their practices before - now they only need to travel three minutes for practice."



Standley Aquatic Center Opens for Lap Swim

The Standley Aquatic Center, adjacent to Swanson Memorial Pool in Standley Park, is a joint use facility with the San Diego Unified School District. The Aquatic Center facility is ideal for competitive swimming, water polo and lap swimming. Operational hours are limited to high school swim teams at this time.

However, the Center is open to the public for Monday through Thursday evenings for Lap Swim. A single visit pass is \$4.00. The Summer hours and programs schedule will start in June. SUMMARY OF UCCA APRIL 13, 2022

Featured Speakers and Public Safety

Col. T.M. Bedell, Commanding Officer of MCAS- He reported on the status of flight patterns for MCAS and took many calls from the public. His background is a Harrier Jet pilot who has flown over 400 combat missions. He was the aviation safety officer and director of the safety division prior to MCAS appointment. In response to questions about noise and pilots not following approved routes, he said the Southern California air space is as dense and complicated anywhere on Earth. MCAS relies on FAA approvals of its air routes and are doing everything they can to make sure pilots do what they are supposed to do. Any visiting squadrons are briefed as soon as they land on the rules for landing, taking off and where to fly. MSAS is trying to minimize noise from Osprey aircraft. If safety issues, pilots try to land at North Island and if equipment malfunction, pilots declare an emergency to get priority handling to land and will avoid housing areas. In response to a questions about (1) access to Rose Canyon east of 805 for biking and hiking, (2) guarterly meeting with the community, MCAS and FAA, (3) getting 100% compliance by pilots, (4) maintenance of the sidewalk along the fence for the base by Miramar Rd., he said he would investigate it.

City Councilmember Joe LaCava thanked Col. Bedell for attending the meeting to discuss issues. He reported (1) Redistricting every 10 years required by the census causes most of UC to be in City Council District 6. The effective date is after the November election. (2) The Mayor has prepared a budget for the City and Town Hall meetings, including one at Doyle Rec. Center and one zoom will be held. (3) The homeless population is increasing east and west of Hwy. 5, as are crimes. (4) Any non-emergency reports of crimes should be on the City's "Get is Done" website to help create a map of where crimes are occurring. (5) City regulations on ADU's does not require the owner to continue to live in the original house though state law requires it. The City has already "up zoned" areas in Linda Vista for ADU's. He said single family zoning is a "thing of the past".

Officer M. Bognuda of SDPD reported they were looking for new candidates. A job fair is scheduled for April 23.

Community Reports

Barry Bernstein, past president of UCCA, reported on the need to get DIF money released for projects in UC. The Mayor's budget does not touch these funds but combines North and South UC funds into a single fund for all of UC which could hurt funding for South UC projects.

Garrett Ashman reported that the City ADU program goes beyond state law requirements, allowing three stories in some areas, and allowing building with no notice to neighbors and controls on design.

Kevin Makinson, of Falck Ambulance, Station 50, said they are completing staffing around the City. When going to a hospital via an ambulance, have all medications for the patient, and clear areas where they must go to get the person out on a stretcher.

Spencer Katz, aide to County Supervisor Terra Lawson-Remer, reported the County is launching "Make County Work for All" a program to help responsiveness to the needs of people. The County was getting more state and federal money for people who qualify to help them from becoming homeless.

Chris Nielsen, Chair of UCPG, reported (1) A town home development for Torrey Pines was approved was approved; (2) The CPUS (Community Plan Update Subcommittee) will meet on April 19; (3) Joe LaCava requested City funding for additional solar panels. (4) Redoing water or sewer pipes not part of Pure Water project are a few years out. Iby Kantor announced "Help Save University City" have circulated a petition to the Mayor to not change zoning of single-family residences in South UC. Over 1,800 signatures have been submitted.

Lily Higman, a candidate for District C of the San Diego Unified School District, explained her positions for the School District.

Kent Lee, a candidate for District 6 of the City Council, stated what he wanted to do for the City. He will attend the debate on April 26.

Helen Liebowitz, Friends of UC Library, announced a book sale on May 21 from 1-5 pm. at the library on Governor Dr.

Merle Langston of Beautification stated she was contacting artists for painting 9 utility boxes. The costs run about \$500 each box and she is seeking sponsors and/or money from the budget.

Barbara Gellman of Neighborhood Watch announced a meeting with Officer Bognuda on April 14. Socks for Safety has generated \$600 to date. NW may also support painting street numbers on curbs.



The Divisions of the San Diego Police Department

Did you know? SDPD is divided into 9 divisions, Northern is just one of them. Each division has their own Police staff. As you can see by the map, Northern is one of the larger divisions that includes Bay Ho, Bay Park, Clairemont Mesa, Clairemont East & West, La Jolla, Mission Bay Park, Mission Beach, Pacific Beach, North Clairemont, Torrey Pines and University City. The police at Northern have a big territory of responsibility 24/7 and need our extra eyes and ears since they can't be everywhere. We need to continue to report 911 crimes and for non-emergency crimes to 619.531.2000.

At our Captain's Advisory Board meeting last month, Capt. Wahl stated that more officers are needed, especially in the beach areas but they don't have enough officers to provide a full force staff. He reported that in the past six months, call volume has increased, traffic accidents have increased, increase in transients, vehicle break ins, grab and runs are affecting several communities and part is due to the trolley. If they could only hire more well trained officers, it would make a world of difference for all divisions throughout the city. Stay tuned to how you can help even more.

Get Involved in the Budget Season Budget season is once again upon us and adopting a balanced budget that maintains and improves services and provides safe neighborhoods is one of my most important responsibilities. The Mayor's Fiscal Year 2023 budget was released April 15. I am hosting two Budget Town Halls with our City's Independent Budget Analyst to help you understand the proposed budget and fiscal considerations. It is also a great opportunity to directly convey your priorities on city services and infrastructure. The first Budget Town Hall will be held on May 2 at 6:00pm and is virtual. The second will be on May 21 at 10:00am and is in-person at Nobel Recreation Center. Register for one or both at https://bit.ly/D1FY23BTH. I hope to see you there.

Get It Done App Building on UC's robust Neighborhood Watch program, a reminder to use the Get It Done app to let us know about trouble spots in the neighborhood. It won't always result in a quick response or fix but it builds a "heat map" of your community and makes it easier for us to demand infrastructure fixes or more officers on patrol.

Infrastructure Investment and Jobs Act Last month, I had the opportunity to meet with federal legislators, department leaders, and decisionmakers in Washington D.C. to press for federal response and dollars to our most pressing regional issues. The meetings also helped ensure San Diego is ready to apply for and receive historic levels of federal funding allocated to cities and states through the Infrastructure Investment and Jobs Act (IIJA). San Diego will apply and compete for local and binational priorities including sustainable infrastructure, regional transport, childcare, housing, and homelessness projects. Thank you to the San Diego Regional Chamber of Commerce for organizing delegates, deputies, and federal staffers who took time to meet with us.

Early Voting Begins May 9 for June Primary

Under the Voter's Choice Act (VCA), voters choose when, where and how to vote. Every active registered voter in San Diego will automatically receive a ballot in the mail nearly a month before Election Day. Ballots start going out in the US Mail the week of May 9 for the June 7, 2022, Primary Election. Elections are no longer a one-day event and there is no need to wait until Election Day to vote. 

University Plan Update Viewpoints

Since the release of the University Community Plan Update Scenarios in February of this year, there have been many concerns by residents of the impact these proposals may make on our community. These center pages are some selected viewpoints on the proposed changes to the University Community Plan.

The following is Katie's statement made at the April CPUS meeting:

As a member of the subcommittee I have attended all but one meeting in the over 3 years of this process. We have spent considerable time on topics like urban planning, space making, identifying and defining the five focus areas, multiple surveys, review of the surveys, mobility, open space, rec centers, parks, public services etc.

All of that was thrown out the window at the February 2022 meeting when the city presented the proposed zoning that was different than anything presented or discussed in the previous three years. It expanded significant upzoning well beyond the focus areas, and these changes were never part of the community engagement surveys.

I, like many others, feel that this was a violation of principles of transparency. Some of the proposals were presented under false labelling, for example presenting the medium density townhouse proposal as "SB9 Implementation." (The presentation described it as SB9 three times, page 49 of Feb. presentation.) This is not SB9. This is upzoning and has none of the protections and provisions of SB9.

I would propose that more time be given to the community for input. And more time to the subcommittee to accept, modify, or reject these proposals. As it stands now, subcommittee members will need to discuss alternatives, and vote on a plan at the next meeting.

We do not have time when the entire community wants to be heard about these unpopular changes. AND THEY SHOULD BE HEARD. But the subcommittee also needs time to propose alternatives and negotiate and vote on a plan. I would expect more from the city after over three years of this process.

On a side note - it would be nice if the minutes for previous meetings were posted on the city website. Recordings didn't start till a year into the process when we switched to zoom. This, again, speaks to a lack of transparency.

Petition Collects More than 2,000 Signatures

A group of University City residents formed the organization *Help Save UC* in March to respond to the proposed Community Plan Update. *Help Save UC* has been collecting signatures on a petition asking the City of San Diego to withdraw the proposal to rezone streets in UC from single-family housing to medium-density townhouses. The petition also requests that the city hold in-person meetings to discuss all proposed changes.

As of late April, the combined total of online and in-person signatures was over 2,200 and growing. The petition was submitted to Mayor Gloria, Councilmember LaCava, and the Planning Department on April 12. In response, at the April 19th Plan Update subcommittee meeting, City representatives stated they were trying to find a venue to hold the May meeting in person.

The UC community showed strong engagement at the April 19th meeting, with more than 450 people attending and an estimated 150 people commenting in the chat, almost all of whom opposed the Plan Update.

SANDAG Population Projections Underlying UC's Community Plan Update

SANDAG's projections of population growth and housing needs are driving the updating of community plans for University City and other neighborhoods. SANDAG's forecasts are based on data through 2016 and predict San Diego will have 100,000 more people in 2025 than it does now. In the decade between 2010 to 2020, however, U.S. Census figures showed San Diego's population grew by less than 80,000 and the County's population, estimated annually by Census, has been falling since 2017.

The forces influencing this "stalling" of San Diego's population growth are unlikely to change in the foreseeable future. Birth rates have steadily fallen over the last decade. The death rate has increased due to COVID-19. Thus, the rate of natural increase (births minus deaths) is falling. Additionally, the rate at which people are migrating out of California was accelerated by Trump's 2017 tax cut, which eliminated state and local property tax deductibility, increasing Federal taxes paid by many California households. The ability to work remotely (perfected during the pandemic) further augmented this exodus. Dramatic reductions in international migration into the U.S. effected by the Trump Administration (long the main source of San Diego's population growth) show no signs of reversal.

Finally, growth at UCSD, whose increase in student, faculty and staff counts was responsible for over 25% of San Diego's overall increase during the last decade, will dramatically slow, having already met their 2035 targets. Thus, the SANDAG population projections driving University City's community plan updates are completely at odds with current reality.



The City of San Diego initiative called *Homes for All of Us* includes three components: a new community plan update framework called Blueprint San Diego to help meet the City's housing and climate action goals, the creation of a Middle-Income Housing Working Group, and the Housing Action Package.

The Housing Action Package aims to implement new state law (including SB9) related to housing development, align the state law with existing city housing programs, and incentivize and promote new housing opportunities throughout the city that San Diegans of all income levels can afford. City of San Diego Planning Department

In February 2022, the Planning Department shared draft land use scenario alternatives for North University City and South University City for discussion at the University Community Plan Update (CPU) Subcommittee meeting. We very much appreciate all the feedback we have heard. It is important to remember the scenarios are in draft form for potential consideration and to gather continuing feedback from the public. No final decisions have been made at this time.

We are continuing to review the public feedback we've received throughout the CPU process, including the recent feedback received since the February meeting. We plan to provide updates at an in-person May subcommittee meeting and then continue to hold additional outreach opportunities. We will announce the location of the May meeting soon.

With the additional input, a Community Discussion Draft Community Plan is anticipated to be released in late Summer 2022 and will then be followed by the Draft CPU. Once the Draft CPU is released, there will be further opportunities for public input, including additional subcommittee meetings. These will take place before the CPU is presented to the City Council for adoption consideration. Public hearings for the CPU are anticipated to begin around Spring/Summer 2023. Housing in University City, and in San Diego, is not an issue of preference. It is an issue of basic needs.

UC San Diego, like the large majority of public universities across the country, is unable to provide all students with housing for four years of their undergraduate experience.

According to the University's 2018 La Jolla Campus Long Range Development Plan extending to 2035, even with 6,700 new beds (26,000 beds total), the University will not be able to provide oncampus housing for the projected enrollment of 42,400 students.

Students will remain a part of University City as both on-campus and off-campus residents.

That's not inherently a bad thing; students contribute to the local economy by paying rent, purchasing goods from local businesses, and supporting a robust public transit system.

UC San Diego students participate in the local community by providing tutoring, sharing parks and open spaces, and hosting events that are open to University City residents.

The unfortunate reality is that 74% of UC San Diego students who live off-campus are housing insecure, based on a report by the Basic Needs Center.

Building high density housing is not only the best way to support these students, but it will also bring benefits to the community as a whole.

With proper planning, new housing will reduce traffic, boost the economy, and open possibilities for new parks and shared spaces. I have confidence that we can build a better future for our community, together.

Since 2018, community stakeholders and volunteer members of the UC Plan Update Subcommittee have contributed thousands of hours to the University Community Plan Update. Community Plans provide the basic outline for land use and development in San Diego neighborhoods. The current UC Plan is 35 years old and needs updating to meet the future needs of city and community. In that sense, the Plan Update is "a message in a bottle" from our generation to the next. As CPU Subcommittee chair, my goal is to foster a Community Plan that balances critical objectives: new and affordable housing, ample room for economic growth, protection of environmental resources, expanded city facilities to serve future growth, sustainable development and mobility patterns to meet the crisis of climate change, and a high quality of urban life.

I regret that the city has proposed land use "scenarios" that provoked such a profound backlash in the community. These proposals lack the balance we need. The "urban village" densities proposed by the city are undesirable anywhere that affordability is a concern. We have a template for high quality, high-rise housing at half these densities on UCSD's East Campus. We should follow it. We must prevent dislocation of community retail by core industry. We must maximize affordable housing choices to assure that UC remains a balanced community, and we should avoid the displacement of current residents through "expulsive zoning." It is lamentable that the proposed scenarios target places of worship, homeowners and moderate-income renters for displacement, but fail to mandate housing on sites owned by big firms closest to the Trolley. At the April UCPU meeting, I proposed 10 specific revisions to redress these imbalances. I urge community members to review the City's proposals and contribute their own suggestions to move us toward a plan that the community can support.

How to visualize the number of new housing units the City is proposing:

- Palisade at Westfield UTC (Nobel & Genesee) has 23 stories, 300 units
- 186 Palisades would be required to add the 56,000 additional housing units
- 116 Palisades would be required to add the 35,000 additional housing units

The City's newly adopted citywide "Parks Master Plan" states:

- "The system should offer safe, convenient access to a park space and recreation programming for everyone."
- "Prioritizing parks in these neighborhoods that are experiencing the greatest rates of residential growth is critical."
- "Great parks feature quality recreational amenities and programs for diverse interests, ages and abilities."

When asked where the parks will be for the tens of thousands of new residents, the City says they will be evaluating the park needs "in the future". That is not acceptable.



Fire Safe your Place to Increase your Wildfire Safety and Home's Survivability

Make simple low-cost changes to your home and landscape starting today. For more information, visit sandiego.gov/fire.

Action Items to Improve Your Home's Survivability:

- REMOVE leaves, pine needles, and other flammable material from the roof, gutters, and on and under the deck to help prevent embers from igniting your home.
- SCREEN areas below decks and porches with 1/8" wire mesh to help prevent material from accumulating underneath.
- COVER exterior attic and soffit vents with 1/8" wire mesh to help prevent sparks from entering your home.
- ENCLOSE eaves to help prevent ember entry.
- INSPECT shingles or roof tiles.
- REPLACE missing shingles or tiles.
- COVER ends of tiles with bird stops or cement to help prevent ember penetration during a wildfire.

Tips for Landscaping Around Your Home:

- REMOVE dead vegetation and other flammable materials, especially within the first 5 feet of the home.
- KEEP your lawn hydrated and maintained. If it is brown, cut it down to help reduce fire intensity.
- PRUNE tree limbs so the lowest branches are 6 to 10 feet above the ground to help reduce the chance of fire getting into the crowns of the trees.
- MOVE construction material, trash, and woodpiles at least 30 feet away from the home and other outbuildings.
- DISPOSE of branches, weeds, leaves, pine needles, and grass clippings that you have cut to reduce fuel for fire.

Despite the growing visibility of the problem in our community, in my opinion as an outreach worker, San Diego's efforts in finding all-encompassing solutions to end homelessness, are both genuine and wide ranging. I applaud our cities 'coordinated outreach' approach in utilizing services from all available organizations to maximize as many opportunities as possible for the clients we serve. Even with strong our efforts to overcome homelessness, individuals in the community can also support the homeless community by getting individuals directly connected to Homeless Service Providers. Getting connected with a Homeless Service Provider will open access to many necessary resources.

Call 211 – Call with the client and have them connect with a 'homeless outreach service provider'. This will open the door to shelter options, benefits, case management, and housing opportunities. Please leave a detailed description of the location and client.

Get It Done app: Provide as much detail as possible about the individual and the encampment. This will get the client connected to SDPD Homeless Outreach Team who can directly connect individuals to Homeless Service Providers and shelter. HOT@pd.sandiego.gov, 619.446.1010.

Telecare Mobile Crisis Response Team: For clients in mental health crisis, this resources provides rapid response behavioral health services with non-law enforcement in person crisis intervention, risk assessment, care coordination, and linkage to behavioral health services 888.724.7240

MCAS Miramar Commanding Officer Col Bedell Addresses UCCA Meeting

Our City Council representative, Joe LaCava, invited Colonel Thomas M. Bedell, the Commanding Officer of MCAS Miramar, to join him at the UCCA meeting on 13 April via Zoom. Col Bedell gave an excellent synopsis of operations at Miramar and clearly expressed his intention to ensure that operations are conducted "by the book". He emphasized that this is particularly important here because San Diego has the most complex and crowded airspace on the planet. Everything fits together like a Swiss watch and in a small space, so any deviations from established procedures and routing reduce safety.

Before taking charge of his new command, Col Bedell was in charge of the entire safety program for the US Marine Corps. He is a graduate of the US Navy's intensive course in aviation safety. He said that noise is part of the safety equation since it can lead to hearing loss in extreme cases. But even at lower levels, loud noise affects many people by making them irritable and distracted.

Col Bedell then took questions from the attendees and responded with detailed and to the point answers to the questions and points made by the members of the audience. It was clear to the audience that he "got it" and gave thoughtful responses to questions. We appreciate the time he took to address our UCCA members... made more impressive by the fact that he was on leave in a different time zone and joined our Zoom meeting from his hotel room.



UC Planning Group Update - April 12

At the April 12 UCPG meeting we welcomed new resident board members Sasha Treadup, area 3, and Andy Wiese, area 1. We also welcomed new business board members Fay Arvin, area 2, Carey Algaze, area 2, Linda Bernstein, area 1, and Steve Pomerenke, area 3. The Board elected Chris Nielsen as Chair, Roger Cavnaugh as Vice Chair, Anu Delouri as Membership Secretary, and Carey Algaze as Secretary. Each will serve until the end of March 2023.

The UCPG heard a project recommendation for the Torrey Pines Fire Station at the request of Project Manager Monica Arredondo from the City's Engineering and Capital Projects Department. The purpose of the request is for input on the project and to be able to include the community recommendation to the Coastal Commission as part of the permitting process. The UCPG discussed several issues with the project, including landscaping, pedestrian and bicycle safety in front of the station, the location of vehicle entry and exit points, new traffic signaling, and the amount of solar power in the station's design. The UCPG voted unanimously to recommend approval of the project as presented, with a vote of 18 Yes, 0 No, and 0 Abstain, with a recommendation to increase the amount of solar power from the initial 10% to 50% within five years. The station's design allows future increases in the number of solar panels as funding becomes available.

Stephanie Saathoff, representing the Towne Centre View project being developed by BIOMED reality, said they will be ready to have a subcommittee meeting on traffic impacts in early May.

Many residents have noted the posting of a Notice of Application for the Easement Vacation for proposed vacation of an open space easement, located at 8293 Gilman Drive, by the Robinson Wood Revokable Trust. I am told by the Planning Department "that nothing in the current Easement Vacation request has caused the department to change its recommendation for denial. The applicant is always allowed to submit more information to be taken into consideration, but nothing to date that has been presented to the Planning Department has changed the department's position since the last time that this issue was reviewed."

PLANNING GROUP REFORM

Planning Group Reform has been on the agenda since 2018 and the process is now coming to completion through the advocacy of District One's Joe LaCava, who presented the current version of PG reform proposals at the April 26 CPC meeting.

Proposed policy supportive of PG functioning preserves indemnification and defense, \$500 stipends, City designated staffing of City Planners at meetings as needed/as available, and provides free City facilities for meetings as well as use of the City website for PG agendas. A free bank account for PG's that want them are available. Changes to encourage more participation and better representation include minimization of attendance voting and candidate requirements, and a 2-year hiatus for renewed membership. To ensure inclusive representation a PG "must demonstrate...that it fairly represents all members of the community and is accessible to all members of the community"[CP600-24 revision]. Renters are to be given a proportional PG membership role as is feasible. There is some flexibility for PGs to tweak membership according to available candidates following a good faith effort to reach out to all stakeholders.

The reform schedule includes Joe's presentation to Land Use & Housing in June; and tentatively in July a City Council vote followed by a summer 2023 limit to file documents for PGs to be certified in late 2023 by the City in Council as compliant with the revised CP-600-24. The larger questions concerning this reform package involve whether or not there is an attempt to limit community input. This concern is shared by a number of PG Chairs and other involved community members, one of whom was recently quoted in the *Del Mar Times/San Diego UT* [3.14.22] as saying, "My personal opinion is that most of this is being pushed by the Planning Department and industries and organizations that benefit from pro-density, massive housing development, in order to get any community opposition out of the way quickly." We will discuss this issue and the PG reform package at the next UCPG meeting on May 10.

Community Plan Update Subcommittee (CPUS) Meeting Recap

Agenda and supporting documents for this meeting, and previous meetings can be found at planuniversity.org. The meeting was held as a webinar. The focus of the meeting was a brief discussion of the city's proposed changes to South UC focusing on the shopping center proposals and a longer discussion of changes proposed for North UC. Nancy Graham is the new city planner assigned to the plan update following Katie Witherspoon's resignation.

Public Comment:

Diane Ahern: Invited people to the LWV D6 Candidate forum. Pointing out that most of the University Planning area will be in D6 after the election.

Katie Rodolico: Questioned the process and lack of transparency from the City. Asked that minutes be posted to the city website.

CM Joe LaCava: His office is listening to the community about the proposed rezoning.

Ruth DeSantis: Would like to see current infrastructure (parks, rec centers, etc) improved before discussing new infrastructure.

Isabelle Kay: Worried the plan process creates silos between different, but adjoining neighborhoods. Felt not all densification should be along the trolley line.

John Mattison: Discussed studies about upzoning and how it doesn't solve affordable housing.

Tommy Hough: Running for D6. Suggested people attend LWV forum. Was concerned about the townhouse zoning in South UC.

Kent Lee: D6 candidate. Has heard feedback while canvassing.

Jo Nagel: Upset that the upzoning came out of nowhere.

Agenda Items:

Nancy Graham introduced herself. Presented a timeline for future meetings. May's meeting will be in person or hybrid. Location TBD. Topic will be continued land use discussion. The city will provide a revised land use plan at the June meeting. The subcommittee will have the opportunity to discuss and propose alternatives to the city's proposal.

South UC discussion:

Nancy Graham reviewed the south UC medium townhouse zoning proposal. She compared it to SB9, showing the similarities and differences. Andy Weise pointed out the east area proposed Urban Employment Village has issues with overflight and noise from Miramar and that the single egress road in case of fire was an issue for residential use.

Debby Knight pointed out the east area also had no public transportation and would not help climate action goals.

Petr Krysl requested the planning department refer to the area as University City, not University.

Community members made statements about the proposed upzoning to medium density townhouse. The very large majority were against the proposed upzoning.

North UC discussion: Nancy Graham showed an updated map that showed the Vista La Jolla SFRs had been revised to reflect lower density. (Previous version had converted density to high rise tower density.) She asked for feedback on what incentives should be offered to developers for providing low income housing units.

Katie Rodolico asked about the change in zoning from prime industrial to mixed use. She suggested that increased development should not allow 'in lieu fees', that developers be required to provide low income housing units.

Andy Weise discussed the need to protect community commercial spaces such as grocery stores, retail, and dining. Specifically the LJ Village area and the area at Regents and La Jolla Village. He requested language be put in to protect lower income residents from being displaced by luxury development similar to what is in the Barrio Logan plan.

Community Members discussed the increased density and whether it was needed at this level or at all. **Dr. Richard Carson** (UCSD) discussed the inaccuracy of Sandag's growth projections and how even their growth projections were lower than what the city was proposing for growth.

Nancy Graham stated these changes were required under state laws such as AB32.

The next CPUS meeting will be in May. Location and format (in person, hybrid, zoom) to be determined. To register for notifications on meetings go toplanuniversity.org/contact.
